- **4. Online Form:** the Online Form must be completed in full and must include a copy of the original invoice which clearly shows the Eligible Appliance(s) purchased and paid for in full within the Offer Period. The Eligible Appliance's serial number must be sent to **enquiries@boschpromotions.com.au** by **30 September 2024.**
- **6. Nature of the Bonus:** claimants will receive a confirmation email once the Online Form is submitted and received by the Promoter. If the claim is successful, the Bonus will be delivered to the Australian residential address provided by the Claimant within 60 days of the claim being validated. Multiple Bonuses permitted subject to complying with these Conditions.
- **7. Verification:** the Promoter reserves the right, at any time, to verify the validity of any claimant (including a claimant's identity, age and place of residence).
- **8. Discretion:** the Promoter reserves the right, in its sole discretion, to disqualify any claimant who the Promoter has reason to believe has breached any of these Conditions, tampered with the claim process or engaged in any unlawful or other improper misconduct calculated to jeopardise the fair and proper conduct of the Offer. Any misrepresentation or fraudulent information supplied by a claimant disqualifies their claim.
