

# Terms and Conditions

## Q1 2024 Smeg Sale

Promotional Period: 1 March 2024 – 1 April 2024

1. Information on how to claim and the offer form part of these Terms and Conditions ("Terms and Conditions"). Participation in the Q1 2024 Smeg Sale ("The Offer") deems acceptance of these terms and conditions. Claimants must comply with these Terms and Conditions.
2. The Promoter is Smeg Australia Pty Ltd ABN 33 146 901 082 ("Promoter" or "Smeg")
3. The Promotion commences at 9:00am (AEST) on Friday the 1<sup>st</sup> of March 2024 and closes at 11:59pm (AEST) on Monday the 1<sup>st</sup> of April 2024 ("Promotional Period"). The Promotional Period may be extended at the sole discretion of the Promoter. Purchases made after the Promotional Period will not be accepted.
4. The Offer is only valid for purchases of any Participating Product in Australia.
5. The Offer is:

  - ii. "Participating Product" means any of the Smeg products listed by model name and number that are supplied by Smeg in Australia and sold by a Participating Retail Store, subject to these Terms and Conditions;
  - iii. All colours are applicable to this Promotion.
8. Normal manufacturer's warranty conditions apply.
9. The Offer does not include the following products:
  - i. Wholesale complementary products or accessories;
  - ii. Any factory second or items purchased from an auction house;
  - iii. Display models; and

10. Any costs, fees, expenses, or liability of any description to pay any amount for installation, insurance, warranty or extended warranty, delivery or any other costs that is, at the determination of the Promoter is its absolute discretion, additional or ancillary to the models listed above.

The Digital Prepaid Mastercard requires activation within 60 days from the date of issue and is valid for 12 months once activated.
15. Any ancillary costs associated with redeeming a Digital Prepaid Mastercard are not included in this promotion. Any unused balance of a Digital Prepaid Mastercard will not be awarded as cash.
