Cordless Go GWP Terms and Conditions

- 1. Information on how to purchase a Cordless Go Starter Kit forms part of these Terms and Conditions (Terms). These Terms apply to the KitchenAid Australia Cordless Go Starter Kit Promotion 2024 (Promotion) and participation in the Promotion is deemed acceptance of these Terms and Conditions.
- 2. The promoter is KitchenAid Australia Pty Ltd (ABN 50 601 363 419) of 6-8 Billbrooke Close, Cameron Park NSW 2285, Australia, telephone (02) 4902 6500 (Promoter).

Definitions

- 3. For the purposes of these Terms and Conditions:
- a. Participating Product(s) refers to the KitchenAid Go Cordless Hand Mixer and the KitchenAid Go Cordless Hand Blender. The eligible models of the Participating Products that form part of this Promotion are 5KHMR700A (RRP \$199) and 5KHBRV00A (RRP\$199). The Participating Products are subject to stock availability.

Promotion entry details

- 4. The Promotion will be open from 9:00am AEST on Wednesday 18 July 2024 and will close on 11:59pm AEST on Friday 28 February 2025 (Promotion Period). Purchases made outside the Promotion Period are not subject to this Promotion.
- 5. Entry is open to Australian residents aged 18 years and over (Eligible Claimants).
- 6. Employees, directors, management and contractors of the Promoter and other agencies, firms, retail staff or companies associated with the Promotion, and their immediate families, are not eligible to enter. By entering this Promotion you represent that you are eligible to enter. Immediate family means any of the following: spouse, ex-spouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step-parent, grandparent, step grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or first cousin.

How to enter the Promotion

- b. When purchasing the Participating Product online from a Participating Retail Partner, the Eligible Claimant must add the Participating Product together with one (1) KitchenAid Cordless Go Battery (SKU number 5KRB12A, RRP \$69) (together, the Cordless Go Starter Kit) to their cart in

order to be eligible to purchase the Cordless Go Starter Kit at a discounted price of RRP \$199. The discounted price is calculated against the RRP of \$268 for the Cordless Go Starter Kit.

- 9. There is no limit to the number of Cordless Go Starter Kits an Eligible Claimant may purchase, provided that the Eligible Claimant fulfills the requirements in clause 7 above for each purchase.
- 10. The Promoter reserves the right to disqualify Eligible Claimants if proof of age or identity has not been provided, or the Eligible Claimant has not otherwise complied with these Terms. The Promoter's decision is final on all matters and no correspondence will be entered into.
- 11. The Promotion is not available in conjunction with any other promotion, offer or discount unless otherwise specified.

Cordless Go Starter Kit details

- 12. Commercial sales, second-hand purchases, refurbished products, trade seconds products, insurance claims, purchases denoted "Clearance" (including seconds) or special offers are excluded from this Promotion, and any Participating Products purchased in these ways will not be eligible for this Promotion or included as part of a Cordless Go Starter Kit.
- 13. Should the KitchenAid Cordless Go Battery become out of stock, the Promoter reserves the right to provide an alternative item of the same or higher retail value. The KitchenAid Cordless Go Battery is not transferable or exchangeable by the Eligible Claimant. All other costs associated with the KitchenAid Cordless Go Battery are the responsibility of the Eligible Claimant.
- 14. The Eligible Claimant shall accept the Cordless Go Starter Kit as described in these Terms and acknowledges that the Promoter accepts no responsibility for any variation in value, or for any tax liabilities that may arise from purchasing the Cordless Go Starter Kit. The Recommended Retail Price (RRP) includes GST and is suggested only.
- 15. Any costs incurred by the Eligible Claimant associated with this Promotion including making telephone enquiries in relation to the Cordless Go Starter Kit are the sole responsibility of the Eligible Claimant.

Other Terms

16. Nothing in these Terms limits, excludes or modifies, or purports to limit, exclude or modify the statutory consumer guarantees as provided under the Australian Consumer Law, as well as any other implied warranties under the Australian Consumer Law or similar consumer protection laws in Australia ("Non-Excludable Guarantees"). Except for any liability that cannot by law be excluded, including the Non-Excludable Guarantees, the Promoter (including its respective officers, employees and agents) excludes all liability for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of the
