Subject to State or Territory regulation, if an event beyond the control of the Promoter corrupts or affects the administration, security, fairness, integrity or proper conduct of this Competition, any aspect of this Competition is incapable of running as planned (including by reason of computer virus, communications network failure, bugs, tampering, unauthorised intervention, fraud, technical failure), or a change is required to ensure the safety of the Promoter, its representatives and of entrants, the Promoter reserves the right to amend, cancel or suspend this Competition, invalidate any affected entries and suspend or modify a Prize.
