#### **Who can enter**

16. The Promoter reserves the right to amend, cancel or suspend this Competition if an event beyond the control of the Promoter corrupts or affects the administration,

security, fairness, integrity or proper conduct of this Competition or if such a change is required to ensure the safety of the Promoter, its representatives and of entrants. Such changes may include the timing of the drawing or redrawing, and the timing of any Prize fulfilment. The Promoter will act reasonably and in good faith in making any such decision.
